REQUEST FOR PROPOSAL/QUOTATION (RFPQ)

Within the project *“Rescue, return, rehabilitation and reintegration of (potential) victims of trafficking in Moldova.”* IOM will carry out the procurement and installation of the Victim-Witnesses Protection Video Communication system for interviewing vulnerable witnesses in the Prosecutor’s Office in Comrat.

System Description:

This system is composed of audio/video/communication equipment designed for ensuring the physical safety and protecting the confidentiality (if necessary) of witnesses in criminal cases, while providing testimonies in criminal proceedings. The system allows testimony to be taken from the endangered witnesses in secure locations by video link. During the court proceedings, the (victim) witness is placed in a separate room –“secret room”, which is situated outside of the court room. Hidden microphones and earphones are installed in the secret room and allow audio and video communication from the secret room to be broadcasted to court room.

IOM reserves the right to accept or reject any quotation, and to cancel the procurement process and reject all quotations at any time prior to award of Purchase Order or Contract, without thereby incurring any liability to the affected Supplier/s or any obligation to inform the affected Supplier/s of the ground for IOM's action.
